BACKGROUND

In response to a gap in the availability of second- and third-line treatment options for HIV-infected children and adolescents in the landscape of rapid scale-up of antiretroviral therapy (ART), Johnson & Johnson Global Public Health, the Elizabeth Glaser Pediatric AIDS Foundation (EGPAF), and the Partnership for Supply Chain Management launched the *New Horizons Advancing Pediatric HIV Care Collaborative* in 2014. Since its establishment, several additional partners have joined the initiative, including Right to Care, the Relevance Network, and the Collaborative Initiative for Paediatric HIV Education and Research (CIPHER) of the International AIDS Society (IAS).

The mission of the Collaborative is to advance a holistic, integrated approach to high quality and sustainable pediatric and adolescent HIV care and treatment with a particular focus on those in need of second- and third-line medication. Key objectives of the Collaborative include: 1) addressing the gap between pediatric and adult HIV and AIDS treatment; 2) targeting challenges sustainable ART sustainability service delivery for children and adolescents; and 3) building awareness of and confronting challenges faced by adolescents concerning disclosure, adherence, psychosocial support, retention, and transition to adult care.

As a first step under the New Horizons Collaborative, a DRV/ETR *Donation Program* was launched in 2014 to increase access to pediatric HIV medicines for children experiencing ART failure. Under this program, Janssen is providing DRV (PREZISTA®) and/or ETR (INTELENCE®) free of charge to eligible national HIV/AIDS programs in sub-Saharan Africa, for use in children and adolescents up to 19 years of age. Upon turning 19 years (or before as required by the national HIV/AIDS program), patients using donated products will be transitioned into the countries' HIV treatment programs for adults as designated by the national HIV program.

PURPOSE/SCOPE OF WORK

In 2018, EGPAF began a multi-country study to collect cross-sectional demographic and clinical data at baseline and every six months for patients receiving donated products across participating New Horizons donation program countries. This activity will comprise data abstraction of a key demographic, clinical, laboratory and case history indicators and outcomes on each patient who ever received DRV and/or ETR provided through the Donation Program.

This RFP seeks consultants to support this study in the following countries: Ethiopia, Nigeria, Rwanda, and Zambia.

CONSULTANT RESPONSIBILITIES:

1. Ensure the safety and well-being of all study participants and scientific integrity of the study in-country.
2. Ensure the development of study-specific operating policies and standard operating procedures.
3. Responsible for completion and submission of the initial protocol package to all relevant institutional review boards/ethics committees (IRBs/IECs) according to the IRB/IEC requirements, ensuring that the same versions are approved by all IRBs/IECs prior to study implementation.
4. Responsible for ensuring that subsequent amendments and annual progress reports are submitted to all IRBs/IECs in a timely fashion.
5. Communicate directly with the local IRB/IEC, ensuring approval is received for the study and notifying the agency of research-related issues, as required.
6. Communicate directly with the local Ministry of Health stakeholders to build buy-in for the study, as required.
7. Monitor study progress with ongoing review of study implementation (timely enrollment, quality of data, follow-up rates, and overall progress in achieving study objectives). This requires conducting regular site visits, leading regular meetings with study team, and maintaining close communication with all Principal Investigators and Study Investigators.
8. Oversee all aspects of in-country data management.
9. Implement data entry and management activities, including data quality control.
10. Work closely with the Senior Biostatistician/Co-investigator to ensure high quality data collection, management, and analysis.

CONSULTANT DELIVERABLES

1. Country-specific data collection plan for the New Horizons study submitted to local IRB.
2. Initial protocol package submitted to all relevant IRBs/IECs.
3. Data collected every six months through the end of 2021 at all sites in the country receiving donated ARVs through the New Horizons donation program.

MINIMUM REQUIREMENTS:

1. Previous experience with data collection, management, and analysis (required).
2. Knowledge of local research regulations, requirements, and IRB/IEC processes (required).
3. Currently permitted to work in the country where the consultancy will be located (required).
4. Knowledge of second- and third-line antiretroviral therapy (preferred).

FOUNDATION RESPONSIBILITIES:

1. Orient consultant the study and drug donation program.
2. Share study-specific SOPs and other guidance.
3. Provide ongoing and routine support and communication during study implementation.

LOGISTICS:

The services will be provided at sites receiving antiretrovirals through the New Horizons drug donation program. Some annual travel and other travel (domestic and/or out of country) may be required. All travel must be specifically authorized in advanced by the Foundation.

KEY CONTRACT TERMS:

The anticipated contract type is a labor hour contract plus travel expenses in accordance with the Foundation’s travel policies. Unless stated otherwise in the statement of the work, the Consultant is responsible for providing equipment and/or supplies required to perform the services.

All deliverables provided to the Foundation must be furnished for the use of the Foundation without royalty or any additional fees.

All Materials will be owned exclusively by the Foundation. Consultant will not use or allow the use of the Materials for any purpose other than Consultant’s performance of the Contract without the prior written consent of the Foundation.
